Is my water safe?

We are pleased to present this year's Annual Water Quality Report (Consumer Confidence Report) as required by the Safe Drinking Water Act (SDWA). This report is designed to provide details about where your water comes from, what it contains, and how it compares to standards set by regulatory agencies. This report is a snapshot of last year's water quality. We are committed to providing you with information because informed customers are our best allies. Last year, we conducted tests for over 80 contaminants.

Only two contaminants, by-products of disinfectants, were detected at a level higher than the EPA allows. Public notices were posted, as required, to inform the community that our water temporarily exceeded drinking water standards. (For more information see the section labeled Violations and Exceedances at the end of this report.)

Do I need to take special precautions?

No, McGrath's water is regularly tested and is safe to drink. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/Centers for Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Water Drinking Hotline (800-426-4791).

Where does my water come from?

The public water system for the City of McGrath, Alaska, is a surface water system that obtains water near the center of the village from the west bank of the Kuskokwim River. Water from the river is settled, filtered, treated for particulate matter, chlorinated, and stored in two storage tanks near the water treatment facility.

Source water assessment and its availability

Source water assessments have been completed by the ADEC as a first step towards voluntary local source water protection efforts. Vulnerability rankings are assigned based on the susceptibility of the time drinking water source, recent sampling results, and the presence of potential contaminant sources – they do not necessarily indicate these contaminants will reach your source of water. The McGrath Water system had a source water assessment completed in January 2004 and received the following vulnerability rankings:

The overall protection area received a susceptibility rating of "very high". In addition, this water system has received a vulnerability rating of "high" for bacteria/viruses, "very high" for nitrates/nitrites, "very high" for volatile organic chemicals, "high" for heavy metals, "very high" for other organic chemicals, and "high" for synthetic organic chemicals.

Why are there contaminants in my drinking water?

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's (EPA) Safe Drinking Water Hotline (800- 426-4791). The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity: microbial contaminants, such as viruses and bacteria that may come from sewage treatment plants septic systems, agricultural livestock operations, and wildlife; inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm water runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming; pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential

uses; organic Chemical Contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems; and radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities. In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

How can I get involved?

If you are interested in learning more about our water system and about opportunities for public participation in decisions that may affect the quality of the water, please contact the City office. Opportunities to get involved include attending or becoming a member of the McGrath City Council, Public Works and the Water Committee. Council meets the 4th Tuesday of each month at 7pm in the Cap'n Snow Center. Committees meet as needed.

Monitoring and reporting of compliance data violations

1) Chlorination

Chlorine is used as a disinfectant to kill microbes in our drinking water. Some people who use water containing chlorine well in excess of the MRDL could experience irritating effects to their eyes and nose and/or experience stomach discomfort. At low levels chlorine can be less effective as a disinfectant. We are required to test the chlorine level at the entry point to the distribution daily and the distribution chlorine level once per month at the same time/place as the Total Coliform sample. We did not report a distribution chlorine residual in July 2017. We returned to compliance in August 2017. Some people who use water containing chlorine well in excess of the MRDL could experience irritating effects to their eyes and nose and/or experience stomach discomfort. At low levels chlorine can be less effective as a disinfectant.

2) Operator Reports

We are required to submit monthly operator reports to the State Drinking Water Program. We did not submit the monthly report on time for July 2017, but returned to compliance in October 2017. These reports include the level of chlorine and turbidity in the water. Turbidity has no health effects. However, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses, and parasites that can cause symptoms such as nausea, cramps, and diarrhea and associated headaches.

Additional Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. McGrath Water System is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components.

When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Water Quality Data Table

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of contaminants in water provided by public water systems. The table below lists all of the drinking water contaminants that we detected during the calendar year of this report. Although many more contaminants were tested, only those substances listed below were found in your water. All sources of drinking water contain some naturally occurring contaminants. At low levels, these substances are generally not harmful in our drinking water. Removing all contaminants would be extremely expensive, and in most cases, would not provide increased protection of public health. A few naturally occurring minerals may actually improve the taste of drinking water and have nutritional value at low levels. Unless otherwise noted, the data presented in this table is from testing done in the calendar year of the report. The EPA or the State requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not vary significantly from year to year, or the system is not considered

vulnerable to this type of contamination. As such, some of our data, though representative, may be more than one year old. In this table you will find terms and abbreviations that might not be familiar to you. To help you better understand these terms, we have provided the definitions below the table.

Haloacetic Acids (HAA5)

Some people who drink water containing haloacetic acids in excess of the MCL over many years may have an increased risk of getting cancer. The violation occurred in July 2016. We are now monitoring quarterly for TTHM and HAA5 and are working to optimize our treatment to limit TTHM/HAA5 formation.

<p>TTHMs [Total Trihalomethanes] Some people who drink water containing trihalomethanes in excess of the MCL over many years may experience problems with their liver, kidneys, or central nervous system, and may have an increased risk of getting cancer. The violation occurred in July and December 2017. We are now monitoring quarterly for TTHM and HAA5 and are working to optimize our treatment to limit TTHM/HAA5 formation.</p>

MCL	MCL: Maximum Contaminant Level: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

TT	TT: Treatment Technique: A required process intended to reduce the level of a contaminant in drinking water.
AL	AL: Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
Variances and Exemptions	Variances and Exemptions: State or EPA permission not to meet an MCL or a treatment technique under certain conditions.
